## DECAL TRANSFER PROCEDURE

THE TRANSFER FEE FOR 2023 DECALS IS **\$40.00** WITH THE RETURN OF THE OLD DECAL (WE ACCEPT THE PIECES OF THE REMOVED DECAL). DECAL TRANSFERS MUST BE MADE IN PERSON. THE NEW VEHICLE MUST BE DRIVEN TO THE NASSAU COUNTY BRIDGE AUTHORITY PARKING LOT TO AFFIX THE NEW DECAL ON THE WINDOW OF THE NEW VEHICLE. VEHICLES MUST HAVE A VALID REGISTRATION AND ONLY THE ORIGINAL OWNER MAY TRANSFER A DECAL. WITHOUT THE RETURN OF THE OLD DECAL, YOU WILL BE CHARGED THE FULL COST OF A NEW DECAL.

YOU MAY **NOT** PLACE THE DECAL ON ANOTHER VEHICLE OR USE IT AN A HAND HELD MANNER. ANY DECAL THAT HAS BEEN ALTERED OR PLACED ON A VEHICLE THAT IS NOT REGISTERED WITH THE NASSAU COUNTY BRIDGE AUTHORITY WILL BE **CONFISCATED** OR **DEACTIVATED** WITH NO REFUND AND YOU WILL FORFEIT ALL DECAL PRIVILEDGES FOR THE CURRENT YEAR.
